EDUCATION GRANT CRITERIA**

1. APPLICANT MUST BE AN EMPLOYEE OF A MINORITY- OR WOMEN-OWNED BANK.
2. EMPLOYEE MUST BE AT THE OFFICER OR MANAGEMENT LEVEL TO QUALIFY.
3. GRANTS ARE OFFERED AS TUITION REIMBURSEMENT ONLY. ALL GRANT AWARDS WILL BE MADE DIRECTLY TO THE BANK. TRAVEL EXPENSES (HOTEL, MEALS, ETC.) WILL NOT BE CONSIDERED.
4. GRANTS ARE ACCEPTED ON A ROLLING BASIS BUT MUST BE SUBMITTED WITHIN 90 DAYS OF COMPLETING THE COURSE.
5. COURSE WORK MUST BE RELEVANT TO THE MANAGEMENT OF A FINANCIAL INSTITUTION OR ADDRESS CURRENT BANKING-INDUSTRY RELATED ISSUES. GENERAL MANAGEMENT COURSES OR COURSES RELATING TO A COLLEGE OR UNIVERSITY DEGREE DO NOT QUALIFY.
6. A MAXIMUM OF \$3,000 PER BANK, PER CALENDAR YEAR WILL BE AWARDED FOR COURSE WORK PROVIDED THROUGH ORGANIZATIONS SUCH AS:

  - ~ BANK ADMINISTRATION INSTITUTE
  - ~ INDEPENDENT COMMUNITY BANKERS OF AMERICA
